## Reading

### KS2 progress [Guidance](#)

- A sentence for key stage 2 progress has not been triggered because the criteria have not been met or the cohort is lower than 11 pupils.
- Reading progress has **declined** between 2017 and 2018.
- Reading progress has **improved** between 2018 and 2019.

### Attainment (all key stages) [Guidance](#)

- A sentence for key stage 2 reading attainment of the expected standard has not been triggered because the criteria have not been met or the cohort is lower than 11 pupils. Key stage 2 attainment of the high standard (110+) in reading (47%) was significantly **above** national and in the **highest** 20% of all schools in 2019.
- The three-year average reading attainment score (107.7) was in the **highest** 20%.
- A sentence for key stage 1 reading attainment of the expected standard has not been triggered because the criteria have not been met or the cohort is lower than 11 pupils. Key stage 1 attainment of greater depth in reading (47%) was significantly **above** national and in the **highest** 20% of all schools in 2019.
- A sentence for phonics has not been triggered because the criteria have not been met or the cohort is lower than 11 pupils.
- Early years foundation stage attainment of the expected standard in the reading early learning goal (93%) was significantly **above** national and in the **highest** 20% of all schools in 2018 and 2017.

## Writing

### KS2 progress [Guidance](#)

- Key stage 2 progress in writing (2.6) was significantly **above** national and in the **highest** 20% of all schools in 2019.

- Writing progress has **improved** between 2018 and 2019.

### Attainment (all key stages) Guidance

- Key stage 2 attainment of the expected standard in writing (97%) was significantly **above** national and in the **highest** 20% of all schools in 2019 as well as in 2018 and 2017. Key stage 2 attainment of greater depth in writing (47%) was significantly **above** national and in the **highest** 20% of all schools in 2019 as well as in 2018 and 2017.
- Key stage 1 attainment of the expected standard in writing (87%) was significantly **above** national and in the **highest** 20% of all schools in 2019 as well as in 2018 and 2017. A sentence for key stage 1 writing attainment of greater depth has not been triggered because the criteria have not been met or the cohort is lower than 11 pupils.
- Early years foundation stage attainment of the expected standard in the writing early learning goal (93%) was significantly **above** national and in the **highest** 20% of all schools in 2018 and 2017.

## Mathematics

### KS2 progress Guidance

- A sentence for key stage 2 progress has not been triggered because the criteria have not been met or the cohort is lower than 11 pupils.

### Attainment (all key stages) Guidance

- A sentence for key stage 2 mathematics attainment of the expected standard has not been triggered because the criteria have not been met or the cohort is lower than 11 pupils. Key stage 2 attainment of the high standard (110+) in mathematics (47%) was significantly **above** national and in the **highest** 20% of all schools in 2019 as well as in 2018.
- The three-year average mathematics attainment score (106.7) was in the **highest** 20%.
- Sentences for key stage 1 mathematics attainment of the expected standard and greater depth have not been triggered because the criteria have not been met or the cohort is lower than 11 pupils.
- Early years foundation stage attainment of the expected standard in the mathematics early learning goal (100%) was significantly **above** national and in the **highest** 20% of all schools in 2018 and 2017.

### Other measures in 2019 Guidance

- In 2019, 83% of pupils achieved the key stage 2 expected standard in reading, writing and mathematics, significantly **above** national and in the **highest** 20% of all schools. A sentence for the percentage of pupils in 2019 achieving the key stage 2 high standard in reading, writing and mathematics has not been triggered because the criteria have not been met or the cohort is lower than 11 pupils.
- In 2019, 93% of pupils achieved the expected standard (100+) in the key stage 2 English grammar, punctuation and spelling test, significantly **above** national and in the **highest** 20% of all schools. In 2019, 60% of pupils achieved the high standard (110+) in the key stage 2 English grammar, punctuation and spelling test, significantly **above** national and in the **highest** 20% of all schools.
- In 2019, 100% of pupils achieved the key stage 2 science expected standard, significantly **above** national and in the **highest** 20% of all schools.
- In 2018, the percentage achieving a good level of development in the early years foundation stage (93%) was significantly **above** national and in the **highest** 20% of all schools.

## Absence Guidance

- In 2017/18, the rate of overall absence (3.30%) was slightly below the national average for schools with a similar level of deprivation (3.47%).
- A sentence for overall absence trend has not been triggered because the criteria have not been met or the cohort is lower than 11 pupils.

## Exclusions Guidance

- A sentence for the rate of fixed period exclusions has not been triggered because the criteria have not been met or the cohort is lower than 11 pupils.
- A sentence for the rate of repeat period exclusions has not been triggered because the criteria have not been met or the cohort is lower than 11 pupils.
- There were no permanent exclusions in 2017/18. The national average for this year was close to zero. There were no permanent exclusions in the previous two years either.

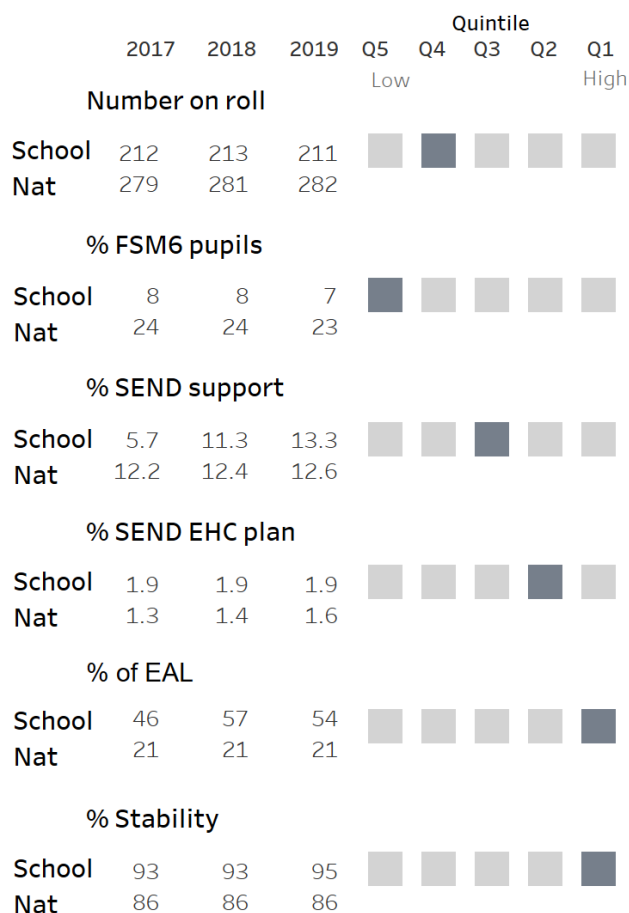
## Pupil groups Guidance

As at October 2019:

- This school is maintained by Enfield local authority which maintains 42 primary schools, 9 secondary schools, 5 special schools, 1 pupil referral unit and no nursery schools.

### School workforce Guidance

As at November 2018, there were:

- 23.1% of teachers with at least one period of sickness absence compared with a national average of 54%.
- 0.2 days on average lost to teacher sickness absence compared with a national average of 4.0.
- no full-time vacant teacher posts in the school.

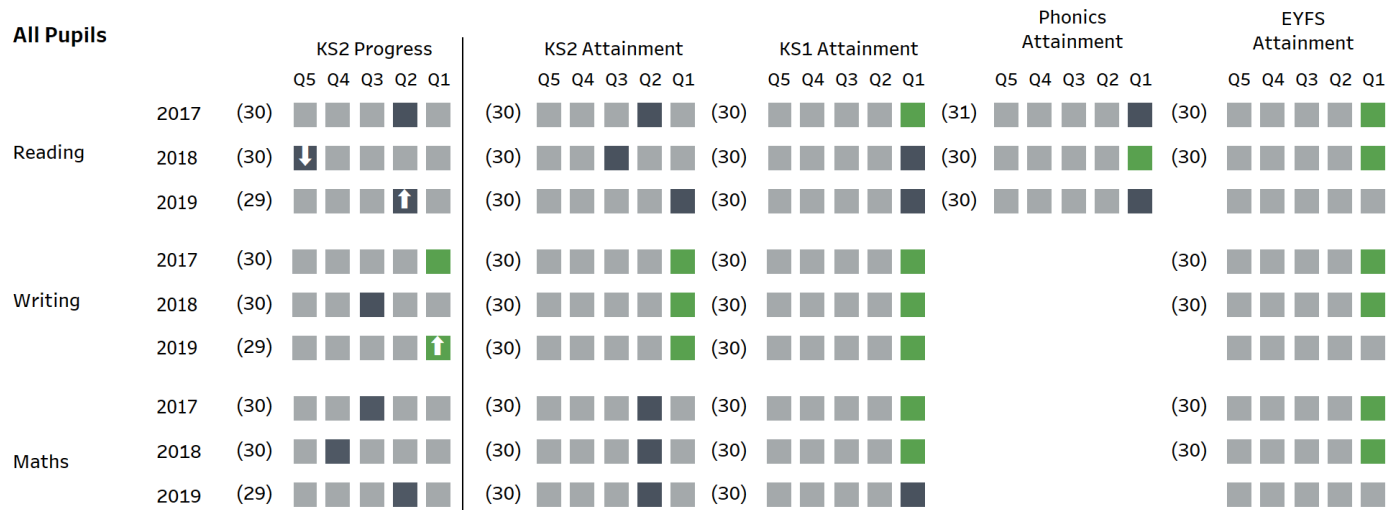
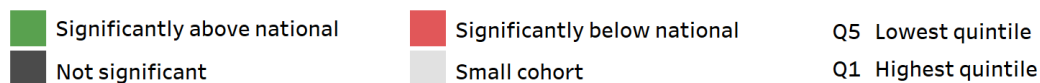
